

He was a letter cutter in the granite industry for most of his career but he also drove trucks, farmed and painted houses. He was a member of the South Ryegate Presbyterian Church. He was a Cemetery Commissioner and a Ballot Clerk for many elections. He also was a Lister for the town from 1961 until 1967 and again from 1970 until 1972. He had a love of history and a great memory for names, dates and events in Ryegate. Bob was always happy to share his knowledge about town history with people and usually did so with a twinkle in his eye.

Selectboard Narrative

The past year has proven to be a busy time for the selectboard with a wide range of issues. From nuisance beavers, messy neighbor complaints, town highway machines, resignations, 250 year celebrations, and road reconstruction just to name a few. Last March after town meeting when the selectboard reorganized, the salaries of the road crew were raised \$.75 per hour. Larry Welch received \$1.75 per hour raise as he is a road foreman with Fred Lakin. We believe this has improved the daily management of the road crew as the selectboard now views a log of daily activities.

The machinery inventory has changed some since last year. The 2001 loader was traded for a slightly used (40 hrs) 2011 John Deere 524K, saving the town \$18,500 compared to buying new. The loader warranty is 4000 hours or 5 years, same as a new machine. After hearing testimony from road crew members concerning the need for a wood chipper to aid in brush cutting the select board decided to purchase a used \$3,500 chipper from Bob Zambon. A new chipper did not seem feasible at a cost of \$20,000.

The road resurfacing portion of the town budget was used on the Creamery Road Project in South Ryegate. Just as a house is only as good as its foundation, a road is only as good as its drainage. Improving the drainage as well as the road base material will give the finished product a longer life span. When the town enters into a project like this it is hard to foresee what complications might occur. Ledge and cracked clay under drain pipe were a couple of problems in this case. The town has adopted codes and standards through VTrans, This requires any new work to meet these standards, 18 inch diameter culverts and 18 inch diameter storm drain pipes. By having codes and standards the town has an opportunity to receive funds for resurfacing class 2 roads or rebuilding town highway structures (bridges). A new sidewalk will be installed in the near future, however the winter maintenance plan of the sidewalk needs to be figured out.

The Creamery Road Bridge #4 replacement project got under way this year with the town applying for and receiving a Class Two Structures grant for Phase 1 of the engineering. The grant is for \$43,591.50, which is 90% of the cost of Phase 1. We will be applying to the same grant program for funding for Phase 2 this year. The board is very pleased that the Historic Preservation office at VTrans have signed on to the idea of replacing Bridge #4 as long as our engineers consider a replacement in kind.

Two town officers resigned during the year. With regrets the select board accepted the resignation of Joan Smith, Lister and Ron Erskine, Animal Control Officer. Thank you both for your years of dedicated service. Bev Allen was appointed as a Lister and the Animal Control Officer remains vacant.

The town now has a website, <u>ryegatevt.org</u>, this should be a great way of accessing various types of information. Thank you Regina Hazel for making this possible.

As we celebrate 250 years of our charter let us remember and give thanks to our ancestors who settled here, embrace the present moment, and instill our values and traditions for future generations to cherish.

Subject: Gravel Road Report

Grant.

I am sorry that it takes so long to get these reports out but I am the only one in our office with the experience to evaluate and report on the status/needs of gravel roads. Many towns are taking advantage of our technical assistance service and I have been on the road for a good part of the time. Many towns need much more assistance than Ryegate and I mean that as a compliment.

During my visit to Ryegate, I observed that most of the best practices that I would prescribe were in use on a daily basis. The two supervisors that rode with us were very aware of the need to adhere to the kind of techniques that promote drainage and keep the road surface free of defects. Specifically, the items that we discussed were: creating a properly shaped road crown, removing berms from the edge of the road, using good road gravel, and keeping ditches and culverts functional.

Here are the highlights of what I observed:

- General Conditions-Wherever gravel thickness was adequate, a good crown existed. I suggested a few locations where gravel should be added to facilitate better crowning in those areas. One location was a low lying culvert in a shaded area where the ditch was suspected as being a problem but I have suggested that more gravel and a better crown may resolve potholes in this area. I also suggested that one entire road be addressed with more gravel and reshaping of the road along with cleaning some ditch obstructions. Most of the roads that I observed were in very good condition. I was very impressed with the how well these roads have stood up to weather conditions since they were last graded.
- Berm removal was a minor issue. It appears that the Highway Department is paying close
 attention to this issue when doing their road maintenance. There were very few problem areas
 and the ones that we discussed had special problems relating to private property owners not
 wanting the run-off from the road on their land. This is more of a political issue than a technical
 issue. I have advised that the town has some rights and an explanation of those rights could be
 better explained by the Vermont League of Cities and Towns. The best answer is to work with
 the homeowner to resolve such issues. For the most part, your crew needs no direction from

- Vermont Local Road on removing berms from the edge of the road. The roads are currently very well managed in this respect.
- Ditches and Culverts-The highway department does a great job maintaining ditches and culverts. I was able to observe several locations displaying examples good road maintenance that included ditching and culvert installations. For the most part, there were no real issues and work was well thought out and prioritized. I did point out a problem that has been occurring with plastic culverts throughout the state. The HDPE plastic culverts are showing some defects within a short time of being installed. This problem has shown up in all towns that I have visited this summer. This problem does not occur because of a defective product. The HDPE plastic culvert performance depends on good material and compaction. Galvanized steel culverts can survive poor installation with less visible defects but many do separate over time because of poor installation. Recently, we have gotten more questions about these culverts. Vermont Local Roads will be publishing a fact sheet that includes proper procedure for installing these culverts. The update will appear on our web-site, on our list-serve, and probably in our next newsletter. The problems observed in your town were very minor but, as I advised, you should have a procedure for contractors and road crew to follow. Our update will be available for your use in the next 10 days.
- Road Gravel-I was very impressed with the overall condition of your road surface. Despite the recent rainfalls, I observed very few surface defects on your roads. I wondered if all your roads survived as well. This question led to a very long drive over your gravel road network where I observed shaded areas, open road areas, and several roads that utilized gravel from two different sources. Over this 3 1/2 hour drive, I probably traveled most of your gravel road system. This was a very thorough survey and I appreciate that you and your two supervisors took the time to stop in many locations to check the road grading techniques and allow me an opportunity to check the different gravel materials being applied. Both of the road gravels being applied were crushed, processed stone rather than a bank run variety. This is always a first concern as many towns have to rely on bank run gravel that generally performs less well and requires more frequent grading. There are some quarry processed gravels that also exhibit less endurance than others. On Ryegate roads, I observed that there was no appreciable difference it the two gravels being used. Both gravel products performed well and surface defects were not very profound on any of the roads. The only difference that I noted was the color of each material which was the only way I could note that there was a difference at all. As a road base, both materials are working well for summer construction and maintenance. The only thing that I am unable to judge is mud-season repair efficiency and I would always depend on the Road Forman to make that call.
- Road Crew-The Ryegate road crew is observing best practices and providing good management
 of gravel road maintenance. This is one of the better gravel road systems that I have observed
 all summer.

Thanks for the opportunity to visit Ryegate. These types of observations will help other towns as well.

To the Selectboard and Management Town of Ryegate, Vermont

We have audited the financial statements of the governmental activities, each major fund, and the aggregate remaining fund information of Town of Ryegate for the year ended December 31, 2011 and have issued our report thereon dated January 14, 2013. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards and Government Auditing Standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated June 4, 2012. Professional standards also require that we communicate to you the following information related to our audit.

Significant Audit Findings

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by Town of Ryegate are described in Note 1 to the financial statements. GASB 54 "Fund Balance Reporting and Governmental Fund Type Definitions" was implemented during the year and the applications of existing policies were not changed during the year. We noted no transactions entered into by the governmental unit during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the Town of Ryegate's financial statements was:

Professional Auditors' Narrative

 Management's estimate of the depreciation is based on estimated useful lives of the capital assets. We evaluated the key factors and assumptions used and determined that the estimate used is reasonable in relation to the financial statements taken as a whole.

The financial statement disclosures are neutral, consistent and clear.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that are trivial, and communicate them to the appropriate level of management. The uncorrected misstatements of the financial statements were due to unrecorded accrued wages and unrecorded delinquent interest and penalties and related deferred revenue. Management has determined that their effects are immaterial, both individually and in the aggregate, to the financial statements as a whole, which we agree.

We proposed ten adjustments to your financial statements which were accepted and recorded by management. Eight of the adjustments were considered material adjustments. Two were related to reflecting the deferred property tax revenue, two were related to the highway transfers due to the effect of the current operations including the grants, three were to properly reflect some grant activity and one was related to the final adjustment of taxes due to the School District.

Disagreements with Management

For purposes of this letter, professional standards define a disagreement with management as a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated January 14, 2013.

Other Audit Findings or Issues

FDIC Coverage - While conducting the audit of cash we noted the Town had cash on deposit in excess of the federally insured limit in a financial institution. This presents a potential for losses to Town in the event of bank or institutional failure. We suggest that management closely monitor cash balances and transfer excess balances to other banks, where possible, to reduce the potential for loss of monetary amounts in excess of the federally insured level.

Professional Auditors' Narrative

Investment Policy - The Town does not have a formal written investment policy. The Town should formulate and establish a formal written investment policy that details the Board's philosophies, policies and goals (both short and long term). The policy would allow the Board to maximize the income earned on investments at an acceptable level of risk and would safeguard Town's assets against misuse. It should include who has the right to transfer between the investment accounts, transaction amount limits, what kind of investments can be made, and who can authorize purchases and sales. The policy should also address the investment goals of Town, the targeted return for the investment portfolio, the amount of risk that is acceptable, and evaluate the risk/reward of investment alternatives. The investment returns and composition should be analyzed at least quarterly to evaluate performance and adherence to the investment policy. This should greatly enhance Town's income from investments.

Fund Balance Policy - The Town implemented GASB 54 "Fund Balance Reporting and Governmental Fund Type Definitions." However, the Board has not adopted a policy which addresses the Town's ability to classify the components of fund balance. We recommend that the Board adopt a fund balance policy.

With respect to the supplementary information accompanying the financial statements, we made certain inquiries of management and evaluated the form, content and methods of preparing information to determine that the information complies with accounting principles generally accepted in the United States of America, the method of preparing it has not changed from the prior period, and the information is appropriate and complete in relation to our audit of the financial statements. We compared and reconciled the supplementary information to the underlying accounting records used to prepare the financial statements, or to the financial statements themselves.

This information is intended solely for the use of the Selectboard and management of Town of Ryegate and is not intended to be and should not be used by anyone other than these specified parties.

Listers' Report

The Listers assess all properties within the Town of Ryegate. Additionally, we maintain an accurate Grand List by reviewing and updating all property transfers, tax maps, permit work, deeds, surveys, and the Current Use Program.

As of January 2013, Ryegate's CLA (Common Level of Appraisal) has risen from 93.59 to 97.89%. This change reflects values closer to Fair Market Value. Our COD (Coefficient of Dispersion) of 9.19% continues to reflect a relatively high level of equity across taxpayers' assessments.

Our Tax Mapper will be updating maps this year, and the new tax maps will be available in the Town Clerk's Office after September. We strongly recommend that you check your property location and acreage on the tax map; let us know if you feel there is any incorrect information.

IMPORTANT: Taxpayers must again file yearly a **Vermont Homestead Declaration** due April 15, 2013. The state form is HS-122 and also contains the **Property Tax Adjustment Claim**. HS-122's can be obtained online (www.tax.vermont.gov), or from the Income Tax Return booklet or your tax preparer.

REMINDERS:

Please notify the Listers of any change of address, or any changes to your property—including new construction, or major renovations to basements, attics, or unfinished areas. In addition, let us know of any removal of property including tear downs and blow downs.

Please share any surveys you have for your property with the Town Office. Certified surveys are important in creating accurate tax maps and are considered the strongest determinant of parcel ownership, i.e., exact location, size, acreage, etc.

Current Use Program applications are available in the Town Office. Landowners currently enrolled must notify the State of any changes in ownership name and/or acreage (including excluded acreage). Questions about the program can be directed to Property Valuation and Review at 802 828-6636.

Understanding Your Property Tax Bill

Your property tax bill is broken down to show education, highway and town taxes and their respective rates. Your total tax rate is the sum of these rates.

The tax rate is per \$100 of your assessment; therefore, to figure the tax you owe, first move the decimal point in your assessment two places to the left, then multiply that number by the total tax rate.

Town Clerk's Dog License Report

Rabies Vaccination: All dogs must be vaccinated against rabies. The town Clerk is required to see evidence that all dogs are currently protected against rabies. The law requires that a dog of

less than 2 years of age shall have been vaccinated within the past 12 months. After its second rabies shot, an adult dog should be vaccinated every 36 months (3 years). A dog must wear its tag.

Due date: License fees may be paid after Jan 1 and are due April 1 and subject to a 50% penalty after April 1. **Fee:** Due to State regulations, licensing fees are \$12 for males, females or wolf hybrids: \$8 for each neutered dog or wolf hybrid. \$4 from each license is forwarded to the State Treasurer.

Remember: Ryegate enforces a Civil Dog Ordinance (leash law). The Town is in need of an Animal Control Officer. Please contact the town office.

Cemetery Commissioners Narrative

Cemetery Commissioners met periodically throughout 2012 and conducted business when necessary by telephone. (10) lots were sold in Blue Mtn to (2) families and (2) lots in Pinehurst to (1) family. There is no available space left in Hillside or Hall Cemetery; however we do have an occasional burial in Hillside. Anyone wishing to purchase a lot can contact Bill Nelson for Blue Mt. and Rick Colby for Pinehurst Cemetery. They have the maps showing the availability and locations.

The entrance cemetery gates in Hillside were replaced this past year by Vermont Recreation, Monroe, NH. This included the main entrance and walk-in gates (on Rte 302), and the side gate bordering the Davidson property. This improvement was long overdue. Additionally, an established boundary fence bordering Pinehurst and the Johnson property was replaced with new cedar posts and woven wire. That too, was in bad shape and very old.

A lot on the lower west side of Hillside containing old marble tablets was up righted and reglued/cemented by Gandin Bros. this last summer. During the winter of 2011 they toppled over, luckily not damaging or breaking the stone.

Surveying of Pinehurst for expansion is on ongoing project. We are in conversation with Truline Survey, St. Johnsbury, VT for consultation and suggestions. The cemetery now has a road extending through this area and exiting on Pinehurst Road, providing a secondary access to and from the cemetery.

Wingets Lawn Care of Groton again provided the mowing services to all four cemeteries and will be contracted for Year 2013 also. Harvey Ricker (584-3236) and Tony Dennis (584-3110) served as our burial caretakers for Pinehurst and Blue Mt. respectively. Please note they should be contacted for arrangements prior to any burial.

As always, the Commission expresses appreciation and thanks to all of the above for their excellent services provided, our Selectboard and the taxpayers of Ryegate for their continued support. Please feel free to contact any one of us with questions or concerns. Copies of the Ryegate Cemetery by-laws and regulations are available at the Town Office.

Northeast Kingdom Youth Services

NEKYS has been offering vital supportive services for youth and families since 1975. In 2012, we served 4,829 individuals throughout Caledonia and Essex Counties, 58 of those were from Ryegate.

NEKYS is a private, non-profit agency governed by a community based, volunteer Board of Directors. We rely on grants, contracts, and appropriations from the towns we serve to continue our mission. Ticklenaked Pond Association Report

The summer of 2012 on Ticklenaked Pond was focused on Eurasian Water Milfoil removal. We received, for the second year, an Aquatic Nuisance Control Grant in Aid from the State of Vermont Water Quality Division (WQD). The members of the Ticklenaked Pond Association (TPA) spent over 500 hours searching, hand pulling plants, and removing plant fragments from the lake. The dive team of A & E Diving Company were hired and spent 3 weeks in June, August and September suction harvesting milfoil in the deeper portions of the lake that the hand pullers could not reach. The dive team removed over 6000 gallons of the invasive plant. Lack of visibility created challenges for controlling the spread and growth of the milfoil. We are applying for another Nuisance Control grant for 2013 and hope to get more money for the dive team.

We are especially pleased to announce that we anticipate approval this year of a grant in the amount of \$85,400 to fund treatment of the lake with aluminum sulfate (alum), which will neutralize the harmful effects of phosphate deposits that have accumulated in the lake bottom over the past several decades. The presence of phosphorus leads to algae blooms, poor water clarity, and oxygen deprived "dead zones" that affect native plant and fish populations. Remediation of the high phosphorus levels is the culmination of a 16 year effort by the TPA and the WQD to address the problem.

This landmark achievement has been a collaborative effort. All existing sources of phosphorus had to be mitigated before the alum treatment could be considered. WQD spent years sampling and analyzing water samples from all inlet streams and the outlet of the lake, and provided the scientific expertise to enable the grant. State and USDA representatives worked with farm owners in the watershed to reduce field runoff and animal wastes as pollution sources. TPA held seminars for its members, planted shoreline plantings, provided rain barrels, reduced road and driveway runoff, installed beaver baffles in beaver dams and surveyed septic systems around the lake. Members took water clarity readings monthly. The Town of Ryegate administered grants for road and culvert improvements, milfoil removal, and will be the principal for this grant as well.

This winter TPA will work with the Town of Ryegate to secure this grant, get bids for a contractor to install the treatment and to manage and administer the grant. It is with enthusiasm that we report to you our hope that the health of Ticklenaked Pond is on the mend and that water visibility should be much better by Fall of 2013. We encourage you to continue to enjoy the pond, our town treasure, for generations to come.

Vermont League of Cities and Towns

The Vermont League of Cities and Towns (VLCT) is a nonprofit, nonpartisan organization that is owned by its member municipalities and directed by a 13-member Board of Directors comprised of municipal officials from across the state elected by the membership. VLCT's mission is to serve and strengthen Vermont local government.

All 246 Vermont cities and towns are members of VLCT, along with 140 other municipal entities, including villages and fire districts. VLCT provides the following services to its member cities and towns, so that they may provide their citizens with quality services at affordable costs:

- Legal, consulting and education services. In the past year, VLCT responded to more than 3,000 inquiries for assistance from municipal officials. Our Municipal Assistance Center (MAC) conducted 23 workshops and 25 on-site training sessions that attracted more than 1,600 people. Handbooks produced by MAC may be purchased or accessed free of charge on our website at our Resource Library. The Library also contains nearly 1,000 other Electronic documents, including technical papers, model polices and newsletter articles that are currently accessible to the general public. MAC has also retained the services of professionals in municipal finance, administration, and policing to provide consulting advice to towns.
- -Advocacy representation before the state and federal governments to ensure that municipalities have the resources and authority they need to serve their citizens. VLCT is a leader in the education finance debate, enhancing local voter authority in governance decisions, land use discussions, and securing revenues for town highway and bridge maintenance programs. Municipalities will face significant challenges in the 2012 legislature, assuring that they have the financial resources and authority to recover from the effects of tropical storm Irene. -Purchasing opportunities to provide needed services at the lowest cost. Examples include municipal employee health insurance and liability coverage for town operations. The VLCT Health Trust represents the most affordable

option available to provide health insurance to municipal employees. The substantial municipal damages resulting from Tropical Storm Irene made the value of VLCT Property and Casualty Intermunicipal Fund (PACIF) to all our members painfully clear, as members benefitted from the broad coverage, excellent re-insurance, and prompt service and claims payments. These two trusts, with the addition of the VLCT Unemployment Trust, were responsible in 2010 for \$43 million in municipal tax dollars spent for insurance and risk management services.

Northeast Kingdom Human Services

Northeast Kingdom Human Services, Inc. is a private not-for-profit organization serving Caledonia, Essex, and Orleans Counties. It is organized and directed by local citizens who believe that human services should be cost effective and responsive to the needs of our local communities. The mission of NKHS is to enrich communities and enhance the ability of individuals and families to improve their lives.

NKHS serves residents who are challenged by conditions that affect the mind, body, and spirit. During fiscal year 2012, we provided services to approximately 4,216 individuals in our three-county service area, 26 were from your community. NKHS is proud to employ 1 from your community. Fees are charged based on the person's ability to pay. No one is refused services for lack of ability to pay. In the past fiscal year, 87% percent of our revenues came from Medicaid, 7% from grants and contracts, 4% from local and other sources, and 2% from other patient fees. Our program expenses show 59% in the Developmental Services program, 17% Children's Services, 15% Community Rehabilitation and Treatment, 4% Substance Abuse Prevention and Treatment, and 4% Adult Outpatient, and 1% Emergency Services. Please support our Appropriation request for \$500.

We greatly appreciate your interest, your help in letting people know about the services we provide, and your financial support.

Little Rivers Health Clinic

Little Rivers Health Care would like to request appropriations funding from the Town of Ryegate again this year to help support the primary care services we provide to the community. As in past years, we are asking for \$2,000 for the upcoming year. Little Rivers provided services for 397 Ryegate residents last year, which represents ~34% if the town inhabitants. As the only safety net health care provider in our area, Little Rivers is likely the only option for many residents who are Medicare beneficiaries or uninsured. We provide a sliding fee scale for those under the 200% of the Federal Poverty Guidelines, and make deeply discounted medications available to those who can't afford them otherwise. We are very grateful to the Town of Ryegate for its past support of our mission and health care services and we hope that you will continue to support us in the future. Thank you very much.

Green Up Vermont

We also consulted local officials on flood hazard regulation and produced a geo-referenced flood hazard map. Finally, we prepared a Public Assistance/ Emergency Response final damage assessment maps for the Town's highways (in response to Tropical Storm Irene). Catamount Arts

The residents and voters of Ryegate played a very important role in the success of Catamount Arts during 2012. Through support at Town Meeting and by attending many of the films and performances offered throughout the year, the citizens of Ryegate helped to keep the Arts vital and available to all of the residents of the Northeast Kingdom.

In the past year, Catamount has invited and encouraged the residents of Ryegate to participate in many of its community offerings, including the Community Film Series, Independent Lens, the Children's Summer Film Festival and gallery exhibits and receptions. These free events were funded in large measure through appropriations from communities in our area. Catamount has also made its space available for use by organizations in Ryegate and other communities and is fulfilling its promise of becoming a cultural and artistic meeting place for all residents of the area. During 2012, Catamount was able to present more than 125 films and 30 live performances, in large measure due to the generosity of the voters of Ryegate.

Catamount is also very proud of the fact that a sizable portion of its almost 800 members are residents of Ryegate. However, in these tough economic times, Catamount greatly needs and appreciates the financial support of all residents, including the residents of Ryegate. Umbrella

Town Appropriation Request: \$500

It's an unsettling statistic: half of all domestic violence related homicides that occurred in Vermont in 2011 happened here in the communities of the Northeast Kingdom. And for every publicized act of intimate partner violence there are hundreds more that take place behind closed doors. We support the local community through three vital programs: *The Advocacy Program* is the essential safety net for people seeking to escape domestic and sexual violence. This past year, we served 730 women, men and youth and provided 65

In 2011-2012, **55 families strengthened connections with their children in a safe, relaxed and non-intrusive atmosphere.**

survivors with a total of 1504 safe nights in our shelter and safe homes.

Kingdom Child Care Connection supports parents in their search for affordable, high quality child care and helps local providers enhance their programming. Last year, we connected 450 families to financial assistance for child care and offered 177 hours of professional development to the area's 100 child care providers.

Given that some of our services are provided anonymously, it can be difficult to provide precise usage figures for towns. At least 11 Ryegate households and one child care program were served directly by Umbrella in 2012, and the community as a whole benefited from prevention and outreach programs at schools as well as training and consultation for human service and law enforcement professionals. Community support is critical to sustaining our programs and investigating new approaches. We are deeply grateful for Ryegate's support.

Cottage Hospital

Cottage Hospital had its fair share of ups and downs in 2012, with an emphasis on the positive. We have continued to create jobs and improve the overall health of our community. However, as uncertainty looms in policy and regulation of health care, we must all remain flexible and open-minded to future possibilities for our hospital in order to keep us viable and active for years to come.

We have been doing great things with few resources for a long time and the talent and commitment of the staff and providers is amazing. In this uncertain health care climate we are a fortunate community to have so many people committed to the success of this small rural hospital. Although funds are always needed and welcomed, we know there are many worthy organizations also asking for money this year and the Cottage Hospital Board of Trustees has decided NOT to ask the towns for financial support for the 18th consecutive year. We thank you for your continued support and we pledge to continue to do our best to provide you and your families with the highest quality healthcare possible.

Woodsville Area 4th of July Committee

Each year the Woodsville/Wells River Fourth of July Committee has the honor and the challenge of putting on a fun-filled day of activities and entertainment on the Community Field as well as the enormous parade. Along with the incredible man hours needed to do this we also need financial support. The generosity of our towns/municipalities, area businesses and the general public have all kept this celebration going. We have a number of fundraising events. The largest of which is the Souvenir Booklet that the Committee produces, courtesy of Copies and More. Local businesses, towns and individuals donate to the Fourth of July Committee and receive advertising space in this booklet. This booklet also includes a dedication to a community member; 2012 choice was Nancy Ranno; write ups about both the Parade Marshall whom was Wayne Fortier and the Grand Marshall David Keith. Additionally there is an "In Memory of ..." section, where for \$5.00 a loved one can be remembered and honored, important information can be included, as space allows, such as date of birth/death, military rank, etc.

Other fundraising activities include the donation jars placed in many of our area businesses, the \$10.00 raffle tickets which offer a top prize of \$1000.00 and a total of 8 cash prizes ending with four \$100.00 prizes, donation collections along the parade route, in addition to Bingo and "Critter Chip" Bingo on the Community Field. Other monies are received by renting space on the community field to concessionaires and vendors, as well as the amusement company paying to provide rides and some food.

Every year we face some difficult challenges. The 2012 was unique with a major storm which caused some minor damage to tents, and caused many vendors to lose product. NEK Waste Management District Executive Report

The NEKWMD finished 2012 in solid financial condition. Recycling markets were fair to good throughout the year. Stronger than expected revenues for recycling, scrap metal, and the surcharge on trash allowed us to end the year with a surplus of \$42,355.14. Spending for the year was \$13,260 more than budgeted, while revenues exceeded projections by over \$55,600. The sale of recyclables generated \$160,185 in revenues for 2012. That figure represents 25% of the 2012 budget. While strong recycling markets were responsible for some of the excess revenue, surcharge revenues exceeded projections by \$29,000.

The NEKWMD is entering 2013 with a proposed budget of \$679,878 - an increase of 5.8%. However, due to the addition of 3 towns – an 11% increase in population - the surcharge on non-recycled waste will remain the same in 2013 (\$22.55/ton). Our surcharge on trash remains just below the average throughout the State of Vermont.

The District welcomed the towns of Corinth, Glover, and Newbury in 2012. We continue to serve the largest geographical area and largest number of towns (48) in the State. Our population served is 3rd in the state behind only Chittenden Solid Waste District and the Central Vermont Solid Waste Management District.

The Vermont legislature passed Act 148 early in 2012. This piece of legislation includes, among other things, mandatory pay-as-you-throw for trash disposal and phased-in landfill bans for certain recyclables, leaf and yard wastes, and source separated organics. In 2013 the NEKWMD will be looking to assist our members in complying with the provisions of Act 148, strengthen outreach to businesses and seasonal residents, and promote greater participation in recycling programs throughout the Northeast Kingdom.

The NEKWMD was staffed by nine full-time and two part-time employees in 2012. Each of the member Towns is entitled to representation by at least one Supervisor. The Board of Supervisors is the principal authority over the NEKWMD and the primary means of contact with the member towns. The Board of Supervisors meets monthly and sets the direction of NEKWMD policy. The member Towns are also represented through their ability to vote on the NEKWMD budget at their Town Meeting in March.

Since fees for NEKWMD membership (the surcharge on trash of \$22.55/ton) are based on the amount of waste produced, members have a clear opportunity to control their waste management costs. Costs can decrease as waste generation rates decrease and recycling rates increase.

The 46,400 residents of 48 Towns throughout the Northeast Kingdom can be assured that the NEKWMD will continue to address their waste management concerns in a timely and environmentally sound fashion.
