

### Ryegate 250th Recap

Ryegate commemorated its 250th anniversary in 2013 with a year full of activities. After spending nearly a year planning and preparing to celebrate the town's birthday, which was September 8, 1763, four daylong events in four distinct seasons were arranged by the energetic committee of more than twenty volunteers. Chaired by Dover Ford, the committee's leadership included Betty Beauvais-Secretary, Tim Wilson-Treasurer, Sally Wilson-Winter event, John Munson and Mary Dole-Spring event, Pat Crocker-Summer event, and Jackie Sinclair and Khristine Elder-fall event, Cynthia Steil and Janet Berrier- logo and art work contests, Mary Dole-T-shirts and mugs, Jenny Nelson and Nessa Flax-Publicity. The committee knew "it takes a village", and other volunteers were always appreciated.

The town's new website was helpful in this effort: <a href="www.ryegatevt.org">www.ryegatevt.org</a> and there was a blog spot as well: <a href="www.ryegate250.blogspot.com">www.ryegate250.blogspot.com</a> Betsey Nelson Pelletier's winning logo, David Elder's stamp cancellation design and Betty Beauvais' mapping of historical Quest routes demonstrated a special brand and historical significance to the year.

**Winter** The year started with a Winter Carnival at Ticklenaked Pond from noon to 3 pm on January 19. Along with the free husky sled rides, winter activities include ice-skating and broom hockey, ice fishing, sliding with a snowmobile tow, and cross country and snowshoe trails, an ice harvest exhibit by Peggy Pearl, games and singing around the bonfire, hot chocolate, hot dogs and marshmallows, and chili cook-off with plenty of tasters to determine the winner; Laura Marrocchini took top honors. The aerial flyover for a group photo didn't happen due to mechanical difficulties.

**Spring** On April 13, South Ryegate village was the focus for "Maple, Monuments and Memories". The Pancake breakfast with local maple syrup was held at the South Ryegate Presbyterian Church, along with various historical exhibits including the Ryegate granite industry, George Murphy's postcard collection of the village, and Irv Thomae's multi-media presentation on trains in Ryegate. Self-directed sugarhouse visits to the Munsons, the Zambons and others filled the afternoon. The Gandon Bros. memorial stone business was highlighted for its 100 years in business and people enjoyed the tour of their facility presented by three generations of Gandins.



### Ryegate 250th Recap

**Summer** July 20 was the summer event featuring an Ice Cream Social in East Ryegate Village. Home to the Ryegate Historical Society, that building with its vast collections of photos, furniture, and other historical artifacts was open and shared with community members and the public. Music by the Bible Mountain Boys and children playing with wooden toys and old-fashioned games really felt like a step back in time. East Ryegate women- Pat Crocker, Ginny Douse, Cheryl Slayton, Nancy Murray, Barb Vance, and Barb Smith- scooped ice cream and toppings, while everyone visited and relaxed. It was a beautiful day to remember.

**Fall** The town of Ryegate completed its year with the Grand Celebration on September 7, 2013. And it was a day filled with history, agriculture, good food, great music, and lots of fun. Staged in the center of the town, Ryegate Corner hosted this final event. Starting off with a brisk run or walk on the Bayley Hazen Military Road, the 5K event was designed for whole families to participate, including a Tots Run.

Located in the Town House on the hill were several historical exhibits: One-room schoolhouses, early transportation, granite industry, factories and farms, founder James Whitelaw, the Civil War and special documents from the 1700's and Major Thomas Nelson's War memorabilia. Delsie Hoyt shared her lifelong skill for braiding and designing rugs. Postmaster Pat Crocker offered special postage stamp cancellations using David Elder's winning design. Rev. Dwight White, in period costume, read the town charter. Outside, there were working steers, cider pressing and blacksmithing demonstrations, while down at the Grange Hall, children's blue ribbon art work and written themes were displayed and the 250th celebration cake, decorated by Dick Fraser and complete with the town logo design, was served. Kids enjoyed watching the wood turning skills of Dick Montague and tried out many old-fashioned games he provided.

Meanwhile, two historic Ryegate Quests creatively crafted by Betty Beauvais were launched with directions at the Town Clerk's office. Designed like a treasure hunt with written clues, the driving quest encompassed Ryegate's portion of the Bayley Hazen Military Road, while the walking quest for Ryegate Corner led the quester past historical buildings and monuments to its final destination in Blue Mountain Cemetery. A hidden box where you could sign in the log book and take a treasure completed the quest! The 1806 Old Whitehill Stone House in North Ryegate was open for tours.

The morning started with bagpiping by Iain MacHarg, with lunch and dinner music by our local "5<sup>th</sup> Business", whose great harmonization was pleasing to the ear. The Bible Mountain Boys provided country music under the tent behind the Town Clerk's office. Everyone enjoyed Cantrip- a dynamic band from Scotland back up at the Town House and the evening of contra dancing led by David Millstone, an international caller with 30 years experience.

Meals included a soup and sandwich luncheon prepared by the Presbyterian Church women, a pulled pork supper cooked by the Ryegate Fire Department, and breakfast goodies and snacks by Blue Mt. Grange. The committee took pride in a job well done and thanks the many individuals, organizations, and businesses who contributed to the cost of the events and for all of you who took part in this historic celebration of our town of Ryegate.

**Whereas**, in 1912, Louis Gandin, an immigrant from Italy, purchased a granite manufacturing business in South Ryegate, and

**Whereas,** from the start, Louis Gandin and his family have striven to operate their business with the goals of quality, service, and customer satisfaction always in mind, and

**Whereas**, in 1921, Tony Gandin, the younger brother of Louis, immigrated to the United States to join his brother and learn about the Vermont granite industry, and

**Whereas**, when Louis Gandin died at an early age, Tony and his sister-in-law Rose assumed control of Gandin Brothers and operated the business through the Great Depression, and

Whereas, the family's management of the business continued as Tony's son Allen Gandin, who joined the company in 1948, took over Gandin Brothers following his father's death in 1969, and Allen's younger brother Butch, who became a Gandin employee in 1964, became President following his older brother's retirement in 1994, and

**Whereas**, in 1990, after graduating from college, Butch's son Tom joined the family's granite business, representing the third generation to participate in the family enterprise, and

**Whereas**, the family leadership of Gandin Brothers in 2013 includes Butch Gandin serving as President, Tom Gandin as Vice President, and Butch's wife Judith as Secretary and Treasurer, and **Whereas**, a group of extended family members is also employed at Gandin Brothers, making this truly a family enterprise, and


Whereas, Tom Gandin has expanded the family's involvement in the Vermont granite industry beyond South Ryegate, as he has served as President of the Barre Granite Association and currently sits on the Association's Board of Trustees, and

**Whereas,** Gandin Brothers is a granite industry company known for the excellence of its work due to the century-long commitment of the Gandin family and to careful attention to the quality of its products, now therefore be it

### Selectboard Narrative

2013 was fairly typical as we faced basically the same problems, dog complaints, boundary line disputes, road equipment repairs, road side trees that need attention, road repairs and rebuilding, and keeping within the budget.

We finished the Old Creamery Road project with the top coat of pavement and rebuilt the sidewalk. A top coat of pavement was added from Route 302 to Gilfillan Road this year. We met with the state water resources people to address the brook that runs beside Swamp Road, as the retaining wall needs to be shored up before we do any work there. We received a Better Back Roads Grant that we used to start a ditching project on North Bayley-Hazen Road. We replaced culverts, lowered ditches and removed ledge and stone to make draining and plowing better. We hope to apply again to finish the job to the bottom of the hill. Thank you Wayne Berry for letting us put ditching material over the bank on your land. We learned that grant money for the Creamery Road Bridge will not be coming this year but this project is still on our agenda as engineering studies are ongoing.

The year 2013 saw the town celebrate it's 250 year anniversary with four very successful days of activities starting with a winter carnival on Ticklenaked Pond and ending with a full day at the corner. We thank Dover Ford and her group for putting these events together.

This summer a new playground was added to the beach area at Ticklenaked Pond, a great addition for the town. Many thanks to Sarah Despins for spear heading this project, and the many people that volunteered their time to work on this. Some of the money for this was taken from the Nicole Andrea Haynes Memorial Fund.

The Select Board would like to thank Cindy Orr for her years as Assistant Treasurer, and welcome Pat Crocker as the new Assistant. Also we would like to thank Grant Nelson for his years on the board as he chose not to run again. We welcome Sally Wilson as a new Lister, as well as Claudette Sortino as a new member of the Select Board. We also would like to thank all who volunteer their time in any way (Fire Department – Recycling – Website - Attending meetings ) You help make the Town of Ryegate a great place to live.

Below is a copy of the Junkyard Ordinance on the books in many towns in Vermont. The town of Burke recently passed it and it is almost identical to the ordinance in Bradford, West Fairlee, Newfane, and numerous other Vermont communities.

The Selectboard wants the town's input as to whether or not such an Ordinance should be passed in Ryegate. Essentially, the law would define how close to a neighboring property or road a homeowner could store junk vehicles or other materials considered to be junk. It would also define the types of barriers necessary to keep such material out of public view. Please read this proposal for all the specifics.

You will be asked to vote at Town Meeting as to whether you think an ordinance such as this would be beneficial for the residents of Ryegate.

### Junkyard Ordinance

#### **REGULATING OUTDOOR STORAGE OF JUNK AND JUNK VEHICLES**

#### **ARTICLE I. Definitions.**

- a. "Abandon" means to leave without claimed ownership for 30 days or more.
- b. "Abutting property owner" means any person or persons, corporation or other entity that owns, leases, or in any other way uses or controls the real property abutting any portion of the property of another.
- c. "Enforcement Officer" means any [constable, police officer, health officer etc.] appointed by the selectboard (trustees/council) to enforce the provisions of this ordinance.
- d. "Highway" means any highway, road, street or other public way, regardless of classification.
- e. "Household appliance" means any range, stove, refrigerator, washing machine, clothes dryer, water pump, power tool and the like.
- f. "Junk" means old or discarded scrap copper, brass, iron, steel or other metals, or materials including but not limited to tires, household appliances, furniture, rope, rags, batteries, glass, rubber debris, waste, trash, construction debris, plumbing fixtures, or any discarded, dismantled, wrecked, scrapped, or ruined motor vehicle or parts thereof. Any of the above items used in a bona fide agricultural operation are excluded from this definition.
- g. "Junkyard" means any place of outdoor storage or deposit that is maintained, operated or used in connection with a business for storing, keeping, processing, buying or selling junk or as a scrap metal processing facility. "Junkyard" also means any place of outdoor storage or deposit, not in connection with a business, which is maintained or used for the storing or keeping of [four] (optional, could be fewer, but not greater) or more junk motor vehicles which are visible from any portion of a public highway. However, the term does not include a private garbage dump or a sanitary landfill that is in compliance with 24 V.S.A. §§ 2201 et seq. and any applicable state regulations. It does not mean a garage where wrecked or disabled motor vehicles are stored for less than 90 days for inspection or repairs.
- h. "Junk motor vehicle" means a discarded, dismantled, wrecked, scrapped or ruined motor vehicle or parts thereof, an unregistered motor home not connected to water and/or sewer, or a vehicle other than an on-premise utility vehicle which is allowed to remain unregistered for a period of 90 days from the date of discovery.
- i. "Motor vehicle" means any vehicle propelled or drawn by power other than muscular power, including trailers. Functional vehicles and equipment used for agricultural and construction operations are excluded from this definition.
- j. "Traveled way" means that portion of a public highway designed for the movement of a motor vehicle, shoulders, and roadside parking, rest, observation areas, and other areas immediately adjacent and contiguous to the traveled portion of the roadway.

#### **ARTICLE 2. Requirements.**

a. It shall be unlawful to place, discard or abandon junk or [four] (optional, could be fewer) or more junk motor vehicles in a place where any such item is visible from the traveled way of a highway or town road, or visible to an abutting landowner from that portion of the abutter's land used on a regular basis. Any such item so placed, discarded or abandoned is hereby declared to be a public nuisance.

### Junkyard Ordinance

b. It shall be unlawful to place, discard or abandon junk or [four] (optional, could be fewer) or more junk motor vehicles upon the land of another with or without the consent of the owner, when any such item is visible from the traveled way of a highway or town road, or visible to an abutting landowner from that portion of the abutter's land used on a regular basis. Any such item so placed, discarded or abandoned is hereby declared to be a public nuisance. c. A person who wishes to operate a junkyard within the town (village/city) of \_\_\_\_\_\_\_ is required to:

- obtain a certificate of approval for the location of the junkyard, and
- obtain a license to operate, establish or maintain a junkyard from the State of Vermont.
- 1. Certificate of Approved Location. Application for a certificate of approved location shall be made in writing to the selectboard (trustees/council) of the town (village/city) of \_\_\_\_\_\_\_. The application shall contain a description of the land to be included within the junkyard, which description shall be by reference to so-called permanent boundary markers. The procedures to be followed after an application has been made are those specified in 24 V.S.A. §§ 2252-2256, as from time to time amended. NOTE: Additional wording for municipalities having a zoning ordinance and a zoning board of adjustment or development review board established under 24 V.S.A. Chapter 117: "The application shall be accompanied by a certificate from the ZBA or DRB that the proposed location is not within an established district restricted against such uses or otherwise contrary to such zoning ordinance."
- 2. State Junkyard License. The procedures for obtaining a junkyard license from the State of Vermont are those specified in 24 V.S.A. §§ 2261-2264, as from time to time amended.
- d. All junkyards, scrap yards, and places of outdoor storage of junk shall be effectively screened from public view by a fence or vegetation at least eight feet in height. Any fence shall be of sound construction and of solid vertical board or 'stockade' type construction, and shall be maintained neatly and in good repair. Such a fence shall not be used for advertising signs or other displays which are visible from the traveled way of a highway. Any vegetation used for screening shall be of sufficient density so that it effectively screens the area from view. Failure to provide screening as required herein shall be considered a violation of this ordinance.

#### **ARTICLE 3. Enforcement and Penalties.**

- a. Upon receiving written notice from the selectboard (trustees/council) to do so, the owner of any junk or junk motor vehicle discovered in violation of Article 2 of this ordinance shall remove or screen the item(s) or vehicle(s) from the view of the traveled way of the highway or town road. Such items shall also be screened from the view of an abutting landowner as seen from that portion of the abutter's land used on a regular basis. If the owner of the junk or junk motor vehicle(s) does not remove or screen the items from view within 30 days from the date of mailing of the written notice by the selectboard (trustees/council), the selectboard (trustees/council) may notify the appropriate state agency.
- b. Additional Provisions for JunkMotor Vehicles.
- 1. If the owner of the land on which a junk motor vehicle is discovered in violation of Article 2 of this ordinance does not hold title or disclaims title to the vehicle, and the true owner of the vehicle is known or can be ascertained, the true owner shall move, screen or dispose of the vehicle upon receiving written notice from the selectboard (trustees/council).

# Junkyard Ordinance

| 2. If the last known registered owner fails or refuses to reclaim the vehicle upon receiving said written notice, or if after an investigation the owner of the vehicle cannot be ascertained, the selectboard (trustees/council) may notify the appropriate state agency.  3. Further procedures by the state agency are specified in 24 V.S.A. § 2272.  c. A violation of this ordinance shall be a civil matter which may be enforced in the Vermont Judicial Bureau or in the County Superior Court, at the election of the legislative body.  1. Violations enforced in the Judicial Bureau shall be in accordance with the provisions of 24 V.S.A. §§ 1974a and 1977 et seq. A civil penalty of not more than \$ per violation (note: may be up to \$500 per violation) may be imposed for violation of this ordinance.  A. A municipal ticket will be issued 30 (optional, could be fewer) days after written notification of violation is mailed by the selectboard if the violation has not been corrected in accordance with this ordinance. Each day that the violation continues shall constitute a separate violation of this ordinance.  B. For purposes of enforcement in the Judicial Bureau, the town (village/city) [constable, police officer, health officer, municipal attorney, other] shall be the designated enforcement officer(s). Said designee(s) shall issue tickets and may be the appearing officer at any hearing.  2. Violations enforced in the Superior Court shall be in accordance with the Vermont Rules of Civil Procedure. The legislative body may pursue all appropriate injunctive relief. In addition, a civil penalty of not more than \$ per violation may be imposed for violation of this ordinance. A civil action may be initiated within [30 days] after written notification of violation is mailed by the selectboard if the violation has not been corrected in accordance with this ordinance. Each day that the violation continues shall constitute a separate violation of this ordinance. Each day that the violation to be invalid, such finding sha |

### Auditors' Narrative

In accordance with Vermont Statutes Annotated Title 24, Section 1681, the board of auditors has verified the existence of cash balances and examined the accounts and records of town officers. To the best of our knowledge, the financial statements and reports of receipts and disbursements, assets and liabilities contained in this Annual Report present an accurate record of funds handled in the year ending December 31, 2013.

The Town Auditors exceeded their budget during the 2013 year. The reason for this is the Auditors Workshop we attended that was presented by the Vermont League of Cities and Towns in late 2012. During that workshop, it was suggested that the Auditors should be looking at items other than bank accounts and special fund accounts. One of the items mentioned was to verify the Grand List. This has taken much more time than we thought it would and is still not finished. Our hope is to finish verifying the entire list during 2014 and then in the following years we would only verify new evaluations and a small sample of the full list.

### Listers' Report

The Listers assess all properties within the Town of Ryegate. Additionally, we maintain an accurate Grand List by reviewing and updating all property transfers, tax maps, permit work, deeds, surveys, and the Current Use Program.

As of January 2014, Ryegate's CLA (Common Level of Appraisal) has risen from 97.89 to 101.75%. This change reflects Fair Market Value. Our COD (Coefficient of Dispersion) of 8.40% continues to reflect a high level of equity across taxpayers' assessments.

Newly updated tax maps (as of September 2013) are now on display at the Town Office along with orthophoto aerial maps. We strongly recommend that you check your property location and acreage on the tax map; let us know if you feel there is any incorrect information.

**IMPORTANT**: Taxpayers must again file yearly a **Vermont Homestead Declaration** due April 15, 2014. The state form is HS-122 and also contains the **Property Tax Adjustment Claim**. HS-122's can be obtained online (<a href="www.tax.vermont.gov">www.tax.vermont.gov</a>), or from the Income Tax Return booklet or your tax preparer.

#### **REMINDERS:**

Please notify the Listers of any change of address, or any changes to your property—including new construction, or major renovations to basements, attics, or unfinished areas. In addition, let us know of any removal of property including tear downs and blow downs.

Please share any surveys you have for your property with the Town Office. Certified surveys are important in creating accurate tax maps and are considered the strongest determinant of parcel ownership, i.e., exact location, size, acreage, etc.

### Understanding Your Property Tax Bill

Your property tax bill is broken down to show education, highway and town taxes and their respective rates. Your total tax rate is the sum of these rates.

The tax rate is per \$100 of your assessment; therefore, to figure the tax you owe, first move the decimal point in your assessment two places to the left, then multiply that number by the total tax rate.

### Town Clerk's Dog License Report

**Rabies Vaccination:** All dogs must be vaccinated against rabies. The town Clerk is required to see evidence that all dogs are currently protected against rabies. The law requires that a dog of less than 2 years of age shall have been vaccinated within the past 12 months. After its second rabies shot, an adult dog should be vaccinated every 36 months (3 years). A dog must wear its tag.

**Due date:** License fees may be paid after Jan 1 and are due April 1 and subject to a 50% penalty after April 1.

**Fee:** Due to State regulations, licensing fees are \$12 for males, females or wolf hybrids: \$8 for each neutered dog or wolf hybrid. \$4 from each license is forwarded to the State Treasurer.

Remember: Ryegate enforces a Civil Dog Ordinance (leash law). The Town is in need of an Animal

Control Officer. Please contact the town office.

### Ryegate Fire Department Report

This year we acquired a Mini Pumper to replace the Pumper in South Ryegate . We had been looking into replacing this truck but could not justify the \$60,000.00 to \$100,000.00 price tag on a vehicle we wanted to fill the gap in our inventory. The need was for a vehicle that could get into these narrow winding camp and residential roads and be more operator friendly to the younger generation. In visiting with K&T Fire Equipment I was asked if anyone was looking for a Mini Pumper for around \$10,000.00. This truck was delivered new in 1988 to Millinocket but had not seen much service (3000 miles). We purchased the this Ford F-350 6x6 Diesel 500 gpm pump and 200 gallons water tank for \$12000.00. K&T serviced made changes and additions as we requested and we brought it home for under \$20,000.00 dollars.

We have been fortunate this year to gain four new members to the department, three new to the fire service and one trained and former member of a local department.

The lighting in the Corner station has been getting so bad we had only 1 ½ fixtures operating on the west side. After researching the options of replacing ballasts, fixture sockets and tubes, (which are being phased out) retro fitting present fixtures to the new T-8 tubes and replacing all fixtures with LED lighting. We opted to go with replacing the 11 present fixtures with 9 LED's. Our reasoning was that with the state rebate we could purchase new at nearly the same cost as retro fitting and the high efficiency of the LED's would be a cost savings in power usage and cost. We are moving forward in replacing the lighting in the other station and the outside flood lights at both stations with LED lighting.

### **Cemetery Commissioners Narrative**

2013 saw the completion of three projects:

A boundary fence bordering Pinehurst Cemetery and the Robert Johnson residence was replaced by Rick Colby and sons. It is a woven wire/cedar post construction which will survive the elements for many years to come.

New gates for Hillside Cemetery were installed by VT Recreation, Monroe, NH. In addition to the main gate, the side gate and the walk in gate were also replaced. constructed of chain link, these much needed improvements have enhanced the beauty of the cemetery.

Stumping, leveling, seeding and top soil work were completed by Matt Puffer in the Spring in preparation of upcoming mowing season.

A section of Blue Mtn Cemetery was cleaned by Gandin Bros., Inc in time for the 250<sup>th</sup> celebration in the fall. The Cameron granite spiral was also cleaned by Tom Gandin (donated) with the assistance of Mike Blair and his hydraulic lift. Cleaning, straightening and repairing is an ongoing project every year. Mowing for all four cemeteries was again contracted to Wingets Lawn Service of Groton. 3 lots were sold in Blue Mtn Cemetery this year, none in Pinehurst. # **Ticklenaked Pond Association Report**

In 2013 the Town of Ryegate, through the efforts of the Ticklenaked Pond Association, received an Aquatic Nuisance Grant-in-Aid from the Vermont Department of Environmental Conservation in the amount of \$9,100.00. The Grant was awarded to manage and remove the invasive species Eurasian Water Milfoil (EWM) which first appeared in the pond 3 years ago. This was a matching grant, and members of the lake association matched 30% of this award by providing equivalent man-hours used to search, hand pull and remove EWM form the lake and shoreline and administer the project. The monies were used to engage A & E Commercial Diving Co. of Manchester Center, Vt. to perform ten days of suction harvesting. Their efforts were focused on creating a channel thru the heavy growth area from the State boat launch out to the deeper part of the lake. These efforts should slow the spread of the invasion by reducing the plant's fragmentation by boating activity.

A representative group from Ticklenaked Pond Association met with the State's invasive plant specialist and the president of A & E Commercial Diving Co. to discuss the future of EWM in Ticklenaked Pond. The consensus was that suction harvesting and hand pulling, the methods used to date, will not be enough to manage EWM growth. The alternative approach of a chemical treatment to greatly reduce the invasive population is currently under consideration, an option that requires a study to ensure environmental safety. Ticklenaked Pond Association, in cooperation with the Town, will apply for another Grant-in-Aid to fund a plant survey this summer, which is the first requirement in a strictly regulated path to chemical use. The next step will be raising the funds necessary to pay for the procedure and for a five year follow up program required by the State of Vermont.

Regarding another aspect of the Pond's water quality, Ticklenaked Pond Association and the State of Vermont have been working on the reduction of phosphate levels in the lake for many years. For the past 15 years the Association has undertaken a program to eliminate sources of phosphorus pollution. Among these efforts were steps to eliminate agricultural runoff, build and repair culverts, redirect water run-off from driveways with water bars and trenches, install rain barrels on shoreline properties and control of beaver dams and the pollution they cause. Having reduced external sources of phosphorus, the State of Vermont has awarded the Town a grant in the amount of \$95,990 for treatment of phosphorus deposits within the Pond. Treatment is expected to take place in the Spring of 2014. A positive result from the Alum treatment will be a noticeable increase in visibility and clarity in the lake. It is further hoped that this improvement in water quality will also enhance our efforts to control EWM.

The Ryegate community can help the health of Ticklenaked Pond in several ways;

- **1. Wash off your boat before putting it in the lake and after taking it out**. This will ensure the plant is not being transported to or from another body of water.
- **2**. **Remove any floating pieces of EWM you see on the lake.** Fragments that are not attached to the stemmed plant will reestablish themselves as a new plant. A picture and information about EWM is at the State boat launch.
- **3. Pick up any EWM plants on the shoreline.** The plants need to be removed from the beach area, composted or bagged and thrown away.
- **4. Please do not take a motorboat or paddle through a dense patch of EWM.** The plants that have surfaced will fragment and drop to the bottom of the lake, root and become another plant.

#### **Vermont League of Cities and Towns**

VLCT's mission is to serve and strengthen Vermont local government.

All 246 Vermont cities and towns are members of VLCT, along with 140 other municipal entities, including villages and fire districts. VLCT provides the following services to its member cities and towns, so that they may provide their citizens with quality services at affordable costs:

- Legal, consulting and education services. In the past year, VLCT responded to more than 3,000 inquiries for assistance from municipal officials. Our Municipal Assistance Center (MAC) conducted 23 workshops and 25 on-site training sessions that attracted more than 1,500 people. Handbooks produced by MAC may be purchased or accessed free of charge on our website at our Resource Library. The Library also contains nearly 1,000 other Electronic documents, including technical papers, model polices and newsletter articles that are currently accessible to the general public. MAC has also retained the services of professionals in municipal finance, administration, and policing to provide consulting advice to towns.
- -Advocacy. Representation before the state and federal governments to ensure that municipalities have the resources and authority they need to serve their citizens. VLCT is a leader in the education finance debate, enhancing local voter authority in governance decisions, land use discussions, and securing revenues for town highway and bridge maintenance programs. Municipalities will face significant challenges in the 2014 legislature. As little financial resources at the national and state level force more demand for services to the local level.
- -Purchasing opportunities to provide needed services at the lowest cost. Examples include municipal employee health insurance and liability coverage for town operations. The VLCT Health Trust continues to help towns with Vermont Health Connect and to help municipalities not in the exchange secure health insurance through the marketplace. The substantial municipal damage resulting from Tropical Storm Irene and the storms of the summer of 2013 makes the value of VLCT Property and Casualty Intermunicipal Fund (PACIF) to all our members painfully clear, as they benefitted from the broad coverage, excellent re-insurance, and prompt service and claims payments. In 2010, our three Trusts were responsible for \$43 million in municipal tax dollars spent for insurance and risk management services.

#### Little Rivers Health Clinic

We provide a sliding fee scale for those under the 200% of the Federal Poverty Guidelines, and make deeply discounted medications available to those who can't afford them otherwise. We are very grateful to the Town of Ryegate for its past support of our mission and health care services and we hope that you will continue to support us in the future. Thank you very much.

# Northeast Kingdom Learning Services Inc.

Northeast Kingdom Learning Services (NEKLS) is requesting town funds to help support the programs that NEKLS delivers to your area. Adult educational services, job skills, transitional support and family services are some of the many programs that are available to residents of the area. NEKLS also has Community Education Centers in Newport, Hardwick and Canaan, with part-time centers in Island Pond and Gilman.

For over 40 years, NEKLS has been serving the residents of Orleans, Essex and Caledonia counties. Services are provided to people of all ages wanting to earn a high school diploma or GED, to learn basic computer skills, or to improve college and career readiness skills. Our Adult Education program provides a wide variety of free services.

In 2013, NEKLS introduced the NEKLS Mobile Lab to the Northeast Kingdom. The Mobile Lab was funded by a grant from FairPoint Communications and the vehicle to transport the Mobile Lab was generously donated by North Point and the Auto Saver Group. We now have one more way to bring services to the most rural areas of the Northeast Kingdom.

Partnering with local schools, the NEKLS Tutorial program provides academic support to students of all grade levels who may be struggling in school. While parents with children ages 0-6 are able to access help through our Children's Integrated Services program which promotes a child's growth and development and supports families during pregnancy/postpartum and their child's early years.

State and Federal budget challenges continue to impact the funding of community non-profit organizations such as NEKLS. As a result, town funds are vital to our efforts to introduce new instructional options and maintain the same level of high program quality. We hope you will continue to support NEKLS as we look forward to another year of being a supportive partner in the community.

# Northeastern Vermont Development Association

The NVDA- the State's only regional planning commission <u>and</u> economic development corporation- has been serving Ryegate for more than 60 years. We continue to assist local officials with land use, transportation, and emergency planning, and we serve the businesses of the Kingdom, promoting sustainable economic growth.

In 2013, NVDA assisted Ryegate by providing zoning technical assistance, including the preparation of new zoning regulations. We geo-referenced Flood Insurance Rate Maps so that they are available in a digital format for planning purposes. We also updated the Town's All Hazard Mitigation Plan, which was required for a FEMA buy out. For communities and businesses in the region, NVDA is the first contact for information and technical support on land use planning, project development, permitting, financing, and grant assistance. We maintain staff in Newport and St. Johnsbury, which allows us to better meet the needs of our vast region. #### **Catamount Arts**

The residents and voters of Ryegate played a very important role in the success of Catamount Arts during 2013. Through support at Town Meeting and by attending many of the films and performances offered throughout the year, the citizens of Ryegate helped to keep the Arts vital and available to all of the residents of the Northeast Kingdom.

In the past year, Catamount has invited and encouraged the residents of Ryegate to participate in many of its community offerings, including the Community Film Series, Independent Lens, the Children's Summer Film Festival and gallery exhibits and receptions. These free events were funded in large measure through appropriations from communities in our area. Catamount has also made its space available for use by organizations in Ryegate and other communities and is fulfilling its promise of becoming a cultural and artistic meeting place for all residents of the area. During 2012, Catamount was able to present more than 100 films and 30 live performances, in large measure due to the generosity of the voters of Ryegate.

Catamount is also very proud of the fact that a sizable portion of its almost 1,000 members are residents of Ryegate. However, in these tough economic times, Catamount greatly needs and appreciates the financial support of all residents, including the residents of Ryegate. For this reason, Catamount respectfully requests your continued support and appropriation for the coming year.

#### Umbrella

#### **Town Appropriation Request: \$500**

Umbrella exists to ensure that communities in Caledonia, Orleans and Essex counties offer safety, support and options for self-determination to women and families. To this end, we provide the following services:

<u>The Advocacy Program</u> is the essential safety net for people affected by intimate partner violence and sexual abuse. In 2013 we:

- supported 892 individuals with direct advocacy
- responded to an average of 163 crisis hotline calls per month
- housed 26 adults and 10 children in our shelter for a total of 1,073 bed-nights, and
- reached 318 adults and 728 youth with our prevention programming.

<u>Kingdom Child Care Connection</u> is the community-based child care resource and referral center for Caledonia and Southern Essex counties. In **2013 we:** 

- helped 80 families find high-quality child care for a total of 107 children at no-cost, and
- connected over 445 families with the State of Vermont's Child Care Financial Assistance Program.

<u>The Family Room</u> is a supervised visitation and monitored exchange center offering child-centered support for parents seeking to establish or rebuild relationships with their children. Last year we helped 102 children develop safe, healthy relationships with their non-residential parent.

<u>Cornucopia</u> is our newest program geared towards helping women-in-transition achieve economic self-sufficiency. This 17-week job-skills training program introduces women to the culinary arts as they prepare Meals-on-Wheels for Newport-area seniors. To date, Cornucopia has provided 2,096 nutritionally-balanced meals to Newport-area seniors and has recently begun operating a senior meal site once a week.

Given that some of our services are provided anonymously, it can be difficult to provide precise usage figures for towns. At least 8 Ryegate households and 1 child care provider were served directly by Umbrella in 2013, and the community as a whole benefited from prevention and outreach programs at schools as well as training and consultation for human service and law enforcement professionals. Community support is critical to sustaining our programming and discovering innovative new approaches to the work we do. We are deeply grateful for Ryegate's support.

#### **Cottage Hospital**

It has been another very exciting year at Cottage Hospital. We have spent the past year evaluating our community needs and strategy for our future, while recognizing out 110<sup>th</sup> year of successfully caring for our community. Fiscally, Financial Year 2013 closed with a positive bottom line amidst a very challenging time in healthcare. At Cottage Hospital, we are all proud of the personal care that we are able to provide to our patients. Time and time again, we hear about the outstanding care that patients and family members have received while with us.

We know our communities are supportive of our institution, and we are extremely grateful for the financial support that our area towns have provided over the years. Although funds are always needed and welcomed, we know that there are many worthy organizations also asking for money this year. Therefore, the Board of Trustees has decided NOT to ask the towns for financial support for the 19<sup>th</sup> consecutive year. We thank you for your continued support and pledge to continue to do our best to provide you and your families with the highest quality of healthcare possible.

#### Green Up Vermont

The weather warmed up just in time for Green Up Day 2013! Many towns reported an increase in volunteers, with some towns setting all-time records. Coordinators overall reported seeing and collecting less trash. We are beginning to track illegal dumpsites by town as well, with the help of our coordinators. Green Up Day celebrated 43 years in 2013. Green Up Vermont is the not-for-profit 501(c) (3) organization responsible for continuing the success of Green Up Day. The success of Green Up for Vermont depends upon two essential ingredients: one is the combined efforts of individuals and civic groups volunteering to make it all possible; and two, the financial support given by the public and private sectors throughout Vermont. The "State" does not "do" Green Up Day. With your town's help, we can continue Vermont's unique annual tradition of taking care of our beautiful landscape and promoting civic pride so our children grow up with Green Up. Our coordinators tell us that most of their volunteer force is families with young children. Green Up Vermont focuses on education for grades K-12 with activities such as a curriculum for K-4, activity booklets, a story and drawing booklet, and the annual poster and writing contests for grades K-12. Please visitwww.greenupvermont.org to learn more. Careful use of resources minimizes Green Up's costs. The State appropriates funds that cover about 12 percent of our budget. Last year, appropriations from cities and towns covered 18 percent of our budget. These funds pay for supplies including over 46,000 Green Up trash bags, promotion, education, and services of two part-time employees. We ask your community to contribute because when you support Green Up Vermont you are not just supporting a program but Vermont and the people who live – and visit - here.

# **NEK Waste Management District Executive Report**

#### **Executive Committee Report**

The NEKWMD finished 2013 in solid financial condition. Recycling markets were fair to good throughout the year. Stronger than expected revenues for recycling, scrap metal, and the surcharge on trash allowed us to end the year with a surplus of \$49,302.46. Spending for the year was \$7,014 more than budgeted, while revenues exceeded projections by over \$56,317. The sale of recyclables generated \$158,072 in revenues for 2013. That figure represents approximately 25% of the 2013 budget. While strong recycling markets were responsible for some of the excess revenue, surcharge revenues exceeded projections by \$38,069.

The NEKWMD is entering 2014 with a proposed budget of \$694,978 - an increase of 2.2%. However, due to the addition of several towns over the last 2 years, the surcharge on non-recycled waste (trash) will drop \$0.55 per ton to \$22.00 per ton in 2014. Our surcharge on trash remains just below the State average.

The District welcomed the town of Topsham in 2013. We continue to serve the largest geographical area and largest number of towns (49) in the State. Our population served is 3<sup>rd</sup> in the state behind only Chittenden Solid Waste District and the Central Vermont Solid Waste Management District.

The Vermont legislature passed Act 148 early in 2012. This piece of legislation includes, among other things, mandatory pay-as-you-throw for trash disposal and phased-in landfill bans for certain recyclables, leaf and yard wastes, and source separated organics. In 2014 the NEKWMD will be looking to assist our members in complying with the provisions of Act 148, strengthen outreach to businesses and seasonal residents, and promote greater participation in recycling programs throughout the Northeast Kingdom.

The NEKWMD was staffed by nine full-time and two part-time employees in 2013. Each of the member Towns is entitled to representation by at least one Supervisor. The Board of Supervisors is the principal authority over the NEKWMD and the primary means of contact with the member towns. The Board of Supervisors meets monthly and sets the direction of NEKWMD policy. The member Towns are also represented through their ability to vote on the NEKWMD budget at their Town Meeting in March.

Since fees for NEKWMD membership (the surcharge on trash of \$22.00/ton) are based on the amount of waste produced, members have a clear opportunity to control their waste management costs. Costs can decrease as waste generation rates decrease and recycling rates increase.

#### **NEK Waste Management Supervisors Report**

The Northeast Kingdom Waste Management District Is comprised of towns in Essex, Caledonia. Orleans, Washington and Orange Counties and is the largest in area and smallest in population. The district is now 25 years old and the only district that each member towns, voters vote on the budget.

Act 148 is the big item in the district now with all it's mandates to be completed by 2020. Here is a brief description of the items that are going to effect you.

2014 all facilities must accept residential recyclables at no extra cost 2015 recyclables banned from the landfill

2016 leaf, yard and clean wood debris are banned from the landfill

2017 transfer stations must accept food scraps

2020 food scraps banned from landfill

The budget this year is a 2.2 % increase over 2013, in line with the cost of living and mostly due the cost of and volume of diesel fuel.

# Groton/ Ryegate Recycling Attendants Report

2013 was another year of increased volume in recyclables through our facility to include scrap metal and electronics. We did start the Compost collection this summer with a half dozen using the service. It is easy to do and the food that can be composted is most all of your household food scraps.

Act 148 is going to make big changes in how we dispose of our waste, and food waste out of the waste stream is a major part of it. Food waste is one of the waste stream items that can be easily made into a product of great value to all of us, and without great cost .

We had a cement slab made for the scrap metal container so it is up out of the mud and allows the trucker to set it closer to the wall. Thanks to Robert Farquharson for getting that project completed.

Whereas the establishment of a State Bank of Vermont will help towns reduce the tax burden on local taxpayers by offering low cost bonds for infrastructure and a depository for their accounts with competitive interest, and will help create jobs, income, and economic security for all Vermonters by making investments and loans in Vermont's people and economy.

We call on the State Legislature to Create a Public Bank for Vermont which enhances the work of the Vermont Economic Development Agency, the Vermont Student Assistance Corporation, the Vermont Housing Authority, and the Municipal Bond Bank and license them to become a State Bank that accepts deposits from the state and municipal governments and makes partnership loans with Vermont chartered community banks and credit unions to students, homeowners, municipalities and enterprises to make Vermont economically stable, self-reliant and successful.
