


## Dedication



November 15, 1948 – December 29, 2016

Gary Mason grew up in Ryegate and was very proud of his Town. He was a decorated US Army veteran, receiving many service medals, including the honorable Purple Heart, for wounds inflicted in Vietnam. He owned and operated his own business, Gary's Plumbing & Heating. For many years, he monitored the South Ryegate Wastewater System, taking monthly reports and repairing it as needed. Gary enjoyed his friends and neighbors and was good to them. He went out of his way to help them if needed. He was a member of the Ross-Wood American Legion Post #20.



September 13, 1924 – December 29, 2016

Ryegate lost another citizen on December 29<sup>th</sup>. Virginia Peterson Phelps died in North Haverhill, NH. She worked for the US Postal Service and was Postmaster in South Ryegate. She was the first woman elected to the Ryegate Select Board and served in that capacity from 1986 until 1989, acting as Town Clerk for a period of time, and helping to train the current one. ## Selectboard Narrative

2016 saw the Town receive a new town truck. We went back to an International this time due to the fact of a very generous trade in allowance on the old truck. We now are on track to follow our capital needs chart, hopefully keeping each truck 8 or 9 years. We now have an all diesel fleet, so have removed the gas tank and pump at the town garage.

We have just signed an extended warranty for the loader, hoping this will give us 4 or 5 more years on this piece of equipment without a lot of unexpected expense.

The Witherspoon Road Project was completed this fall with the final coat of blacktop. We also received a Better Back Roads Grant to fix the outlet end of the big culvert on North Bayley-Hazen Road. We will continue to apply for this type of grant.

The Terry Hill Bridge Project has been on our radar for some time now. A study was done by the Water Resource People and advised us that whatever we do would not address the flooding condition further down the brook. Their report is included elsewhere in the report, on page 23.

A small piece of property was purchased in South Ryegate to clean up an environmental hazard. This land will be incorporated into the Hillside Cemetery at a later date.

We believe the contracts with the Caledonia County Sheriff's Department and the Vermont State Police are working well. Remember, it's only as good as what they see. If you see something, report it. The Sheriff's Department is helping out with our dog problems. If you know of a problem location let us know so we can tell them.

The Women's Club has bought three new "Welcome to Ryegate" signs that will be installed this spring in each of the villages. We thank them for this addition to the Town.

A big thank you to the Road Crew who put in long hours to keep our roads in great shape, also to the Town Clerk, Listers, Treasurer, Auditors, Ballot Clerks and anyone else who keeps this Town running so well. You make our job so much easier.

## Auditors' Narrative

In accordance with Vermont Statutes Annotated Title 24, Section 1681, the board of auditors has verified the existence of cash balances, and examined the accounts and records of town officers. To the best of our knowledge, the financial statements, reports of receipts, disbursements, assets and liabilities contained in this annual report present an accurate record of the funds handled in the year ending December 31, 2016.

The auditors as a group verify bank accounts and fund balances on a quarterly basis. Individually auditors are verifying accounts and other financial activities conducted by the town commissions, departments, and officers. We reconcile the Grand List and the property information files involved in transfer of ownership and changes of appraised value annually. Following a town wide reappraisal of property the auditors will do a complete verification of all properties. The auditors also performed verification of tax collections, and dog license sales.

During the year the issue of accounting software used by the treasurer came up and much discussion took place. The current software is approximately 10 years old and was designed for personal and small business use. The user tech support provided by the company is very time consuming and in order to prepare some reports duplicate entry of data is required. The Selectboard has included a line item in the budget which will exist for a three year period which all parties believe will permit the installation of the new system designed for use by municipalities during the 2018 calendar year.

We thank the town officers and officials for cooperation in assisting us as we performed our duties.

Last year, Secretary of State Jim Condos announced the launch of VT's new Elections Management Platform. This streamlined the elections administration process, providing voters with greater access to voter specific information. Over 25,000 Vermonters registered to vote online in 2016. ### Listers' Report

The Listers determine all property values within the Town of Ryegate. Additionally, we maintain an accurate Grand list by reviewing and updating all property transfers, tax maps, permit work, deeds, surveys, and the Current Use Program.

As of January 2017, Ryegate's CLA (Common Level of Appraisal) remained stable at 105.55% up from 104.25% in 2016. Although the economic predictions for 2016 sounded encouraging, Ryegate sales remained below assessed values. Because of the low number of valid sales and most sales below assessed values in the category of residential with 6 ac . or less, our COD (Coefficient of Dispersion) went from 8.88% to 15.62%.

September 2015 tax maps are on display at the Town Office along with orthophoto aerial maps. We strongly recommend that you check your property location and acreage on the tax map; let us know if you feel there is an incorrect information. Tax maps will be updated in 2017.

IMPORTANT: **Taxpayers must file a Vermont Homestead Declaration every year by April 15<sup>th</sup>.** The state form is HS-122 and also contains the Property Tax Adjustment Claim. Forms can be obtained online (<u>www.tax.vermont.gov</u>), or from the Income Tax Return booklet or your tax preparer. Property owners can also file their homestead directly online. REMINDERS:

Property changes: Please notify the Listers of any change of address, or any changes to your property—including new construction, or major renovations to basements, attics, or unfinished areas. In addition, let us know of any removal of property including tear downs and blow downs.
Surveys: Certified surveys are important in creating accurate tax maps and are considered the strongest determinant of parcel ownership, i.e., exact location, size, acreage, etc. Please file any surveys you have for your property with the Town Clerk.

**Building Permits**: A building permit is required for any structure 64 square feet or larger. Permits are obtainable from the Town Clerk, or on the town website: <u>www.ryegatevt.org</u>.

Current Use: The Current Use Program has changed their application form and process. New applications are available in the Town Office or online at <u>www.tax.vermont.gov/content/form-CU-301</u>. Questions about the program can be directed to Property Valuation and Review at 802 828-6637.

#### Understanding Your Property Tax Bill

Your property tax bill is broken down to show education, highway and town taxes and their respective rates. Your total tax rate is the sum of these rates.

The tax rate is per \$100 of your assessment; therefore, to figure the tax you owe, first move the decimal point in your assessment two places to the left, then multiply that number by the total tax rate.

The law requires that a dog of less than 2 years of age shall have been vaccinated within the past 12 months. After its second rabies shot, an adult dog should be vaccinated every 36 months (3 years). A dog must wear its tag. Due date: License fees may be paid after January 1 and are due April 1 and subject to a 50% penalty after April 1. Fee: Due to State regulations and a state increase, licensing fees are \$13 for males, females or wolf hybrids. \$9 for each neutered dog or wolf hybrid. Beginning July 1, 2015 - \$5 from each license is forwarded to the State Treasurer. Remember: Ryegate enforces a Civil Dog (leash law). Our Animal Control Officer has retired. ## Ryegate Fire Department Report

This past year has been interesting, as well as informative. We attended training on meth labs, informing us as firefighters to be extremely careful on our responses to structure fires, due to the possible presence of a meth lab. We never thought we would see such a thing in Ryegate. Yet, on June 21st, we responded to a camper fire. Upon entering the scene, the fire crew members, through their training, were very cautious around it due to items found on the scene. State Police determined it was a meth lab. The next day a half dozen members, along with an engine and tanker, stood by to assist the State Hazmat Team as they investigated and determined that it was as we thought. In September another meth lab was discovered on the Ryegate-Newbury town line. Wells River covered that and assisted the Hazmat Team. On October 14, 2016, Ryegate responded to the same residence for a structure fire, and firefighters found material they felt was suspicious, and the second lab was discovered. Structure firefighting is always very dangerous, but with the addition of meth labs, it is even more so, due to the possible presence of the incident being booby-trapped. I would advise residents to be extremely careful about picking up any closed containers out of place, as they may contain material with the potential to explode.

#### Bridge Replacement Study

BRIDGE 21 – TERRY HILL ROAD OVER SCOTT BROOK

Ruggles Engineering conducted a topographic study including Terry Hill, Church Street, the bridge and stream channel. This was conducted to see what should be done, if anything, to correct a flooding problem involving Church Street. The existing condition analysis found the critical location for the study is about 40 feet upstream of the bridge where Church Street is only 3 feet above the bottom of the stream channel. This means the stream overtops the stream bank at 10% AEP and above and will run down Church Street until it runs back into the stream below. The next analysis dealt with replacement of the bridge with a 90 square feet opening and found the stream would still overtop the stream bank at 10% AEP and above, and will run down Church Street until it runs back into the stream below. The third analysis was as if the bridge was removed entirely and the channel was widened to match the existing terrain upstream of the bridge and the northerly wall was removed to allow the channel to match the shape just below the northerly clock wall downstream. Results show the stream will still overtop the stream bank at section 5 during the 10% AEP event. Conclusions were, if a new structure was installed there will only be a slight improvement at the critical section upstream from the bridge. Flooding will still occur at 10% AEP and damage from flood waters will occur downstream of the site. Two recommendations: There needs to be improvements to the channel width downstream from the bridge. There is no need to increase the waterway opening at the bridge site when the channel downstream will immediately restrict the stream flow. Secondly, the ground between the stream bank and Church Street needs to be raised upstream from the bridge in order to direct the stream flow into the structure on Terry Hill Road. It was recommended to leave the existing bridge in place until its useful life has been used up. The full report can be seen at the Town Office.

#### **Ryegate Historical Society**

We began 2016 by developing an exhibit for the Vermont State History EXPO. This year's statewide theme was "The Power of Water in Vermont History", which led us to explore the history of Ryegate's grist mills and saw mills, as well as the Ryegate Paper Mill. Another part of the exhibit was on Ticklenaked Pond, known both for its ice harvesting business, as well as the celebration of our town through the Annual Winter Carnival. This exhibit, which was presented at the EXPO in June, is housed at Whitelaw Hall. In July, Hod Symes entertained us with a talk on the early settlement of Wells River, based on his book "The Cross-Road: A History of Wells River". In August we co-sponsored, with the Newbury Historical Society, an evening with Stephen Long discussing "The Hurricane of Thirty-Eight". At our October meeting, Peggy Pearl explained her task of establishing the St. Johnsbury History & Heritage Center, for the preservation of the town's history.

For the first time, the RHS held a series of Open Houses at Whitelaw Hall, one Saturday each month in the summer. This afforded the opportunity for visitors to peruse our collections, ask questions, add stories and bring donations. We plan to continue this next summer. One of our highlights this year was presenting the Ryegate Cane to Madeline Chase Batten Chaffee, who regaled us with stories of her fascinating life. She was born in 1920 and is still an active member of the VFW & works with the Civil Air Patrol. Soon we are going to order reprints of both Ryegate history books, The History of Ryegate Vermont by Miller and Wells and The Down of the Thistle by Dwight White. We would be very appreciative if people could read these books and let us know of any corrections or additions. We've continued our work on the organizing and cataloging of the collections and made excellent progress; and we are extremely grateful for all gifts of artifacts and photographs donated to expand our collection. Donations pertaining to Ryegate's history may be made through any board member. As a final note, we would encourage your membership and support of the Ryegate Historical Society. The annual dues are minimal and are used to help support our efforts to maintain the historical records of our town. For your membership you will receive our Newsletters, information about meetings and lectures and the satisfaction of knowing that you are helping to preserve Ryegate's history. Ryegate has been confirmed as a planning community by the NVDA board, which allows your community to benefit from a number of planning initiatives. We look forward to pursuing these opportunities with you in the coming year.

#### Vermont League of Cities and Towns

The Vermont League of Cities and Towns (VLCT) is a nonprofit, nonpartisan organization, owned by its member municipalities and directed by a 13-member Board of Directors comprising municipal officials from across the state, elected by the membership. -Advocacy representation at the state and federal levels to ensure that municipalities have the resources and authority needed to serve their citizens.

-Opportunities to provide purchasing of needed services at the lowest cost.

## Ticklenaked Pond Association Report

2016 was a very exciting year for Ticklenaked Pond. We kept our fingers crossed to see if the pair of nesting loons would return to the lake after last year's unsuccessful incubation. There was much anticipation to see if the lake would remain as clear as it had been in 2015 after all the efforts to get the Alum treatment. Visibility varied throughout the summer with depths of 6 meters to the delight of swimmers, boaters and all who use the lake for recreation. The water levels were extremely low due to the lack of rain, and this made it a little easier to pull invasive plants.

The Association continues to battle the invasive species Eurasian Water Milfoil (EWM), which chokes and clogs our waterways, crowding out native plants and entangling propellers, fishing lures and the arms and legs of swimmers. In 2016 the Town of Ryegate was awarded \$13,580.00 from the State of Vermont (Department of Environmental Conservation ) for an Aquatic Nuisance Control Grant-in-Aide grant to manage and remove EWM, which first appeared at Ticklenaked Pond in 2010. A & E Commercial Diving Co. was engaged for 13 days this past summer to harvest EWM through hand pulling and suction harvesting. This was a matching grant, and members of the lake association matched 30% of this award by providing equivalent man-hours to search, hand pull and remove EWM from the lake and shore and administer the project. Collectively, they worked on the lake a total of 317 hours.

All parties were unsure of the impact the alum treatment would continue to have upon the EWM population. 2015 showed results that reducing phosphorus levels in the lake also appears to have starved the invasive species of a source of nutrients and the EWM was depleted drastically. Unfortunately in 2016 the EWM population increased again and A & E Commercial Diving Co. removed more than 141- 20 gallon buckets of Milfoil, compared to 19 in 2015. On a positive note, many native plants continue to spread along the bottom of the lake, competing with the EWM. We have once again applied for a grant in 2017 in order to continue to monitor and manage this invasive nuisance.

We are happy to announce that our pair of loons did return and successfully hatched two large tan speckled eggs on Ticklenaked Pond in 2016. They built a nest in the spring on the field to the left of the State boat ramp. One of the two young loons did not survive. The Vermont Loon Conservation Project informed us that this is not unusual and that we should expect to see them back in the spring to nest again. The conservation group put up signs and roped off an area around the nest so that boaters did not come too close. This is yet another sign of the lake becoming healthier and we are keeping our fingers crossed for their success next summer.

The Ryegate community can help the health and enjoyment of Ticklenaked Pond in several ways;

**1. Wash off your boat before putting it in the lake and after taking it out**. This will ensure the plant is not being transported to or from another body of water.

**2**. **Remove any floating pieces of EWM you see on the lake.** Fragments that are not attached to the stemmed plant will reestablish themselves as a new plant. A picture and information about EWM is at the State boat launch.

**3.** Pick up any EWM plants on the shoreline. The plants need to be removed from the beach area, composted or bagged and thrown away.

**4. Please do not take a motorboat or paddle through a dense patch of EWM.** Each fragment can drop to the bottom of the lake, root and become another plant.

## Northeast Kingdom Learning Services Inc.

Northeast Kingdom Learning Services, Inc. #### Little Rivers Health Care

Little Rivers Health Care would like to request appropriations funding from the Town of Ryegate again this year to help support the primary care services we provide the community. As in past years, we are asking for \$2,000 for the upcoming year. Little Rivers provided services for 323 Ryegate residents last year which represents ~28% of the town inhabitants. As the only safety net health care provider in our area, Little Rivers is likely the only option for many residents who are Medicaid beneficiaries or uninsured. We provide a sliding fee scale for those under 200% of the Federal Poverty Guidelines, making deeply discounted medications available to those who can't afford them otherwise. We are very grateful to the Town of Ryegate for its part support of our mission and health care services and we hope that you will continue to support us in the future. Thank you very much.

#### The Community for Restorative Justice

The Community Restorative Justice Center respectfully requests that the following special appropriation article appear on the 2017 warning for the Ryegate Town Meeting:

Shall the Town vote the sum of \$250 to support the operation of The Community Restorative Justice Center during the ensuing year? The CRJC believes in preventing and resolving conflict in the community using victim and community needs as guiding information in repairing harm and restoring right relations. We work with schools, neighborhoods, and the criminal justice system to respond to community needs as it relates to justice being served. In this process, we use community members to work with their neighbors to resolve conflict and repair harm.

The Community Restorative Justice Center holds restorative justice panel meetings for cases referred directly from law enforcement as well as cases referred from the Department of Corrections. Cases that go through the CRJC have a 27% reduction in recidivism. In the past 12 months, the CRJC heard 2 restorative justice cases involving Ryegate residents. We also support restorative practices at schools in the area. Appropriations from the Town of Ryegate would also give technical support to neighborhood associations as requested. The CRJC mission states that we are committed to providing a safe environment for neighbors and parties to resolve conflict in our communities, to restore relationships, and to take responsibility to repair harms caused. We promote the principles of victim-informed restorative justice that transforms practices in workplace, school, institution, and living spaces throughout Caledonia and southern Essex Counties.

We completed another audit for our office this past year and it resulted in no findings or problems of any kind. The state of the Caledonia County Sheriff's Department is very good. We have kept our rates for service the same for the past few years as we know the times are tough and we want people to feel that they can still afford our services. We continue to add vehicles to our fleet, replacing cars that have served us well. We have thirteen marked cars, a 2014 van for prisoner transports, one unmarked car being used for civil process service. We have a large enclosed trailer that we use as an office at the fair and other security details. This trailer may be utilized as a command post at a mass casualty incident as well. We have an ATV, two golf carts, and two snowmobiles that we use for our snowmobile patrols. With project (ROAD), Responsible Operators Against Distractions, we want to continue to educate operators about phone use and texting while driving. We continue to do town patrols and we feel that the towns that we patrol are a safer place to live & drive in because of our presence. The patrols are community based. Which means each town is different, so the patrols may be different. We are taking a proactive response instead of a reactive response. This effort has helped with both fighting crime and communications with the towns. The Sheriff's Department has eighteen Law Enforcement Officers to start the new year. We have become more active with local schools to ensure the safety of students and staff. We have been involved with drills and evacuation plans and will continue to assist as needed. We continue to look at 24 hour dispatching for the county, in the county, but are unable to do that right now. I'm looking into a different location for the department's office because of the high rent the state wants to charge the county for our current location. If anyone has questions or concerns, please call me at the office. My door is always open. I look forward to serving this county as the Sheriff. We have continued with our great relationship with Northeast Vermont Regional Hospital and are helping them make certain that their patients and staff feel safe while in the hospital. We will again do snow mobile patrols throughout the county. Doing our best to keep the trails as safe as possible, and we will again answer snowmobile related complaints. #### Ųmbrella

Umbrella exists to ensure that communities in Caledonia, Orleans and Essex counties offer safety, support and options for self-determination to women and families. To this end, we provide the following services:

<u>The Advocacy Program</u> is the essential safety net for people affected by intimate partner violence and sexual abuse. We meet the needs of victims in crisis while also offering preventative programming to local schools and youth groups with a focus on gender respect, consent, and healthy relationships. In 2016 we: supported 683 individuals with direct advocacy housed 16 adults and 16 children in our shelter for a total of 2,021 bed-nights, and reached 285+ adults and 1,100 youth with our prevention programming.

<u>Kingdom Child Care Connection</u> is the community-based child care resource and referral center for Caledonia and Southern Essex counties. In 2016 we: helped 108 families find high-quality child care at no-cost, and connected over 564 families with the State of Vermont's Child Care Financial Assistance Program. In addition to our work with families, we also interacted directly with the region's 92 child care providers, offering over 272 hours of professional development opportunities to make sure the people responsible for taking care of our communities' youngest citizens have the tools and resources they need to do their best.

<u>The Family Room</u> is a supervised visitation and monitored exchange center offering child-centered support for parents seeking to establish or rebuild relationships with their children. Last year we helped 110 children develop safe, healthy relationships with their non-residential parent. Additional services such as parenting education, counseling and mediation can also be arranged in order to help families address their unique goals and needs.

<u>Cornucopia</u> is our newest program geared towards helping women-in-transition achieve economic self-sufficiency. This 17week job-skills training program introduces women to the culinary arts as they prepare Meals-on-Wheels for Newport-area seniors. After completing the program women are assisted with securing employment with a local business, in a position that fits their individual strengths and interests. This past year, Cornucopia trained 10 women in culinary arts while providing 33,000 nutritionally-balanced meals to homebound, Newport-area seniors and 2,000 meals at its weekly community meal site.

Given that some of our services are provided anonymously, it can be difficult to provide precise usage figures for towns. At least 21 Ryegate households and 3 child care providers were served directly by Umbrella in 2016, and the community as a whole benefited from prevention and outreach programs at schools as well as training and consultation for human service and law enforcement professionals. Community support is critical to sustaining our programming and discovering innovative new approaches to the work we do. We are deeply grateful for Ryegate's support. Request= \$800.00

## Groton Free Public Library

As you may know, our Library services not only the residents of Groton, but also residents of many of our adjoining towns, including most specifically, the Town of Ryegate and its associated villages. Approximately 11% of our documented patrons are residents of Ryegate. Although we do receive some funding from the Town of Groton, budget restrictions of the town have required us to continually identify additional funding sources. Historicallys, more than 60% of our yearly book budget and 100% of the yearly programming budget comes from donations and other fundraising efforts. We respectfully request a 2017 Town Appropriation of \$500 from the Town of Ryegate.

### NEK Waste Management District Executive Report

The NEKWMD finished 2016 with a 2% decrease in recyclables processed compared to 2015. However, ten towns and eight schools reported increases in recycling. Recycling markets began the year on the low side, but rebounded during late summer and into the fall. Although commodity prices rebounded toward the end of the year, it was not enough to overcome the expenses incurred for equipment repairs in 2016. The District ended 2016 with a deficit of \$53,459. Revenues in 2016 were 5% below projections. While budgeted expenses were 2.4% above projections.

There were no additions or subtractions to the District in 2016. We continue to serve the largest geographical area and largest number of towns (49) in the State. Our population served is 3<sup>rd</sup> in the state behind only Chittenden Solid Waste District and the Central Vermont Solid Waste Management District.

Vermont's Universal Recycling Law (Act 148) guided most of our activities in 2016 and will continue to do so for the next several years. 2017 will see more of the same in helping our member communities comply with Act 148. The NEKWMD will assist 11 Towns with establishing food scrap collection at their transfer stations before July 1, 2017.

The NEKWMD is entering 2017 with a proposed budget of \$755,527 – an increase of 5.3% compared to 2016, but only a 1.6% increase compared to 2015. The surcharge rate of \$23.25 will increase by \$1.00 for 2017 to \$24.25. Our surcharge on trash remains below the State average of \$25.07.

The NEKWMD was staffed by ten full-time and four part-time employees in 2016. Each of the member Towns is entitled to representation by at least one Supervisor. The Board of Supervisors is the principal authority over the NEKWMD and the primary means of contact with the member towns. The Board of Supervisors meets monthly with the District's Executive Director to set the direction of NEKWMD policy. The member Towns are also represented through their ability to vote on the NEKWMD budget at their Town Meeting in March.

Since the surcharge on trash is based on the amount of waste produced, members have a clear opportunity to control their waste management costs. Costs can decrease as waste generation rates decrease and recycling rates increase.

We would like to express our appreciation to our able staff for their continuing commitment to our mission. The nearly 50,000 residents of 49 Towns throughout the Northeast Kingdom can be assured that the NEKWMD will continue to address their waste management concerns in a timely and environmentally sound fashion.

## NEK Waste Management Supervisors Report

In our negotiations with the State for a better contract for the collection of e-waste we made out well with a \$.03 increase. This is providing that we separate TV and computer related items from the rest of the e-waste system. In our attempt to change the way we get our budget approved, the Supervisors turned down the proposal. The proposal would have allowed the Supervisors to vote on the budget versus the present system of each town that belongs to the District to vote on it at Town Meeting. Several towns do not have any other ballot questions. Thus, polls are open in that time period, with personnel being paid to be at the polls all day. The major issue was that the Supervisors felt the voters should be voting on the budget, rather than a Supervisor from each town. Residents should understand that the proposed budget does not come out of town funding. It is funded by the sale of recyclables, the surcharge on trash, and state grants.
